On October 10, 2024, the IHS issued a Dear Tribal Leader Letter initiating consultation on the proposed reorganization of the IHS Headquarters Office of the Director, which specifically impacts the structure of offices under the Deputy Director for Intergovernmental Affairs. Which, among other things, would combine the Office of Tribal Self-Governance with Contracting Tribes.

This proposed change is part of the One IHS initiative that aims to improve effectiveness and efficiency across the Agency through greater coordination and collaboration. The primary objectives of the One IHS initiative are to:

- 1) Strengthen relations with Tribal Nations and Urban Indian Organizations through streamlining and enhancing communications.
- 2) Enhance business relationships with Tribal Nations through Self-Determination and Self-Governance.
- 3) Expand Agency work with all partners through intergovernmental and external partnerships.
- 4) Modernize the way the Agency supports Tribal Nations pursuing ISDEAA opportunities by supporting ISDEAA negotiation teams across the Agency working under a One-ISDEAA model.
- 5) Fosters education and training throughout the entire IHS system on how ISDEAA interfaces with Agency's everyday work.

This session will provide an opportunity for TSGAC and IHS to discuss potential impacts of the proposed reorganization, clarify how the reorganization will allow the IHS to meet the objectives listed above, identify a timeline and the anticipated next steps for reaching a decision, and any other matters that either partner may want to address.
