
OSD Leadership Structure

Additions to Self-Governance & Self-Determination

- Cherokee Nation assumed the Claremore SU facility on 10/01.
- Colville Tribe (T1) assumed the Colville SU on 10/1.

- OSD authorized two additional tribes for entry into Self-Governance anticipate transfer from TI to TV in FY26
- OSD Streamlined process to ensure requests for entry into Self-Governance program are addressed within 30-days.
 This was met during FY25.





Administration of the Indian Health Service Tribal Self-Governance Program

- 1. FY2020 and FY2021 Complete Posted to GPO website November 26th.
- 2. FY2022 and FY2023 Tribal comments closed on November 11th no comments received working on final internal clearances
- 3. FY2024 Currently drafted pending 2-3 more success stories.

Contract Support Costs

- 1. FY 2020 and FY 2021 Under final review with HHS, pending submission to Congress.
- 2. FY2022 and FY2023 Reviewing report to make 508 compliant.
- 3. FY2024 Internal IHS review complete submitted to HHS for initial review in Nov 2025.

^{*}Framework for FY2025 report being finalized - data collection will begin in January 2026.

- Over \$3.2 billion of the IHS budget was transferred to Tribes and Tribal organizations

Approximately 65% of budget is transferred to Tribes with recent federal assumptions Oct 1.





OSD closely coordinated with OFA to ensure timely processing of FY26 payments. Areas and HQ staff met daily to ensure all funding for executed agreements was distributed within 10-day timeframe.
